Implementation of Fortification Project: The WPPS has concluded an agreement with Micronutrient Initiative on April 26, 2004, as per decision of the last Executive Committee. In order to implement the project following sub-committee was constituted with Mr. R.P. Jain who remains member, as the Chairman of the WPPS.

WPPS/MI FORTIFICATION PROJECT TERMINATED

Due to poor response from prospective participating millers, Mr. R.P. Jain, the then Chairman, WPPS mutually terminated the project with the Micronutrient Initiatives (MI). This was effective from October 1, 2004. As such, grant received from MI was refunded after adjusting all the expenditures/liabilities as of September 30, 2004.

BAKERS' DAY CELEBRATION:

WPPS supported Bakers' Day Celebration, organized by Society of Indian Bakers on October 8-9, 2004. On this occasion, following activities were conducted:
